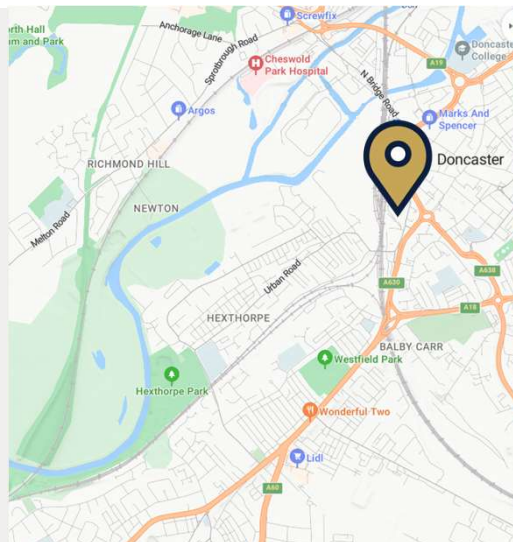




LOCATION

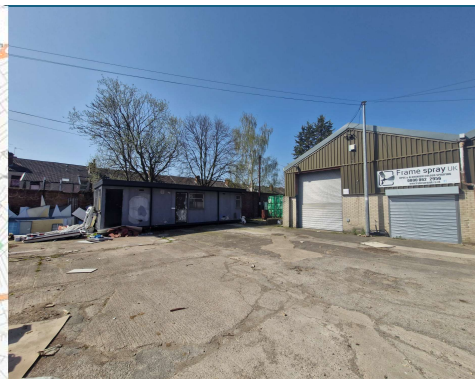
